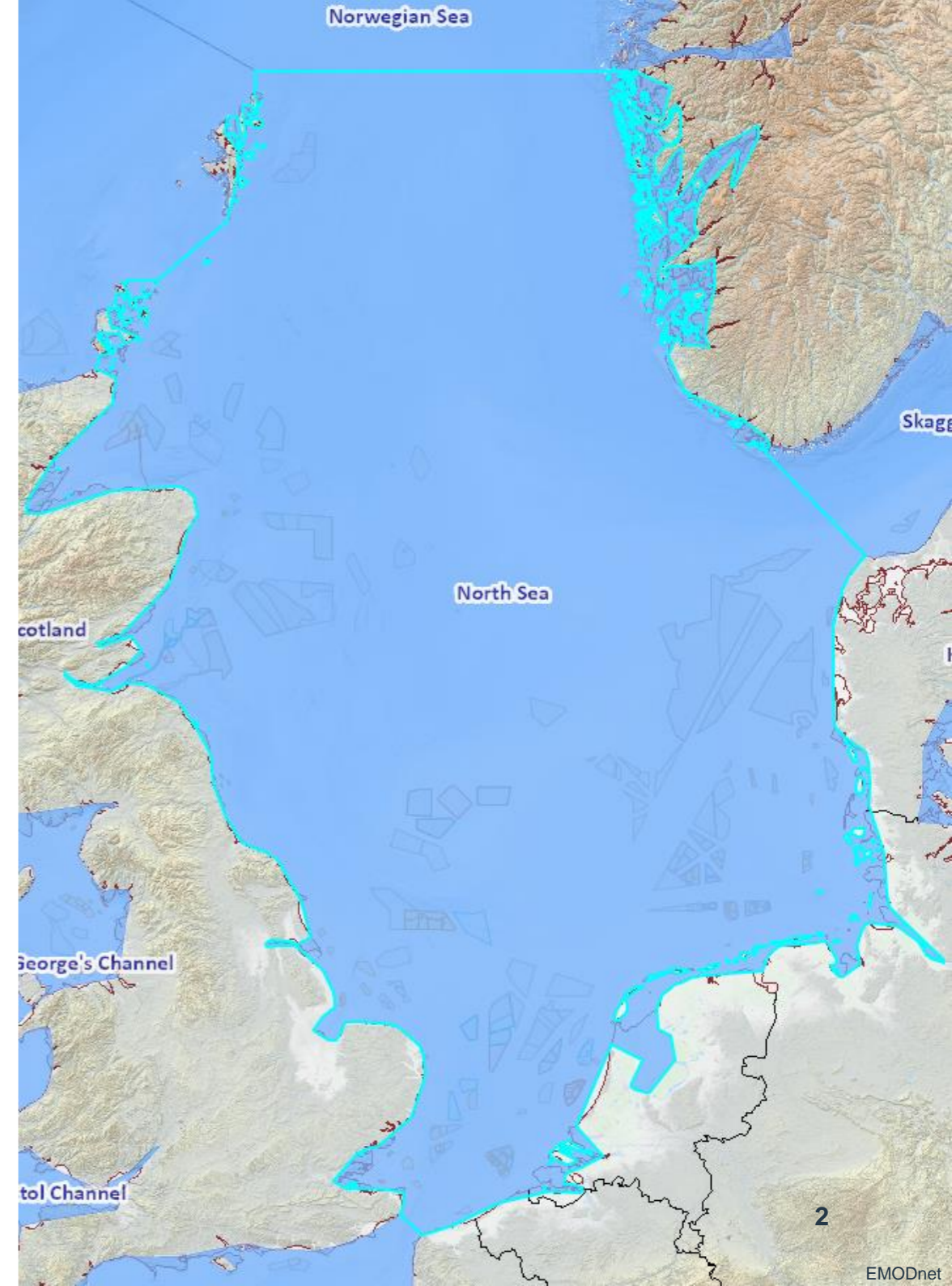

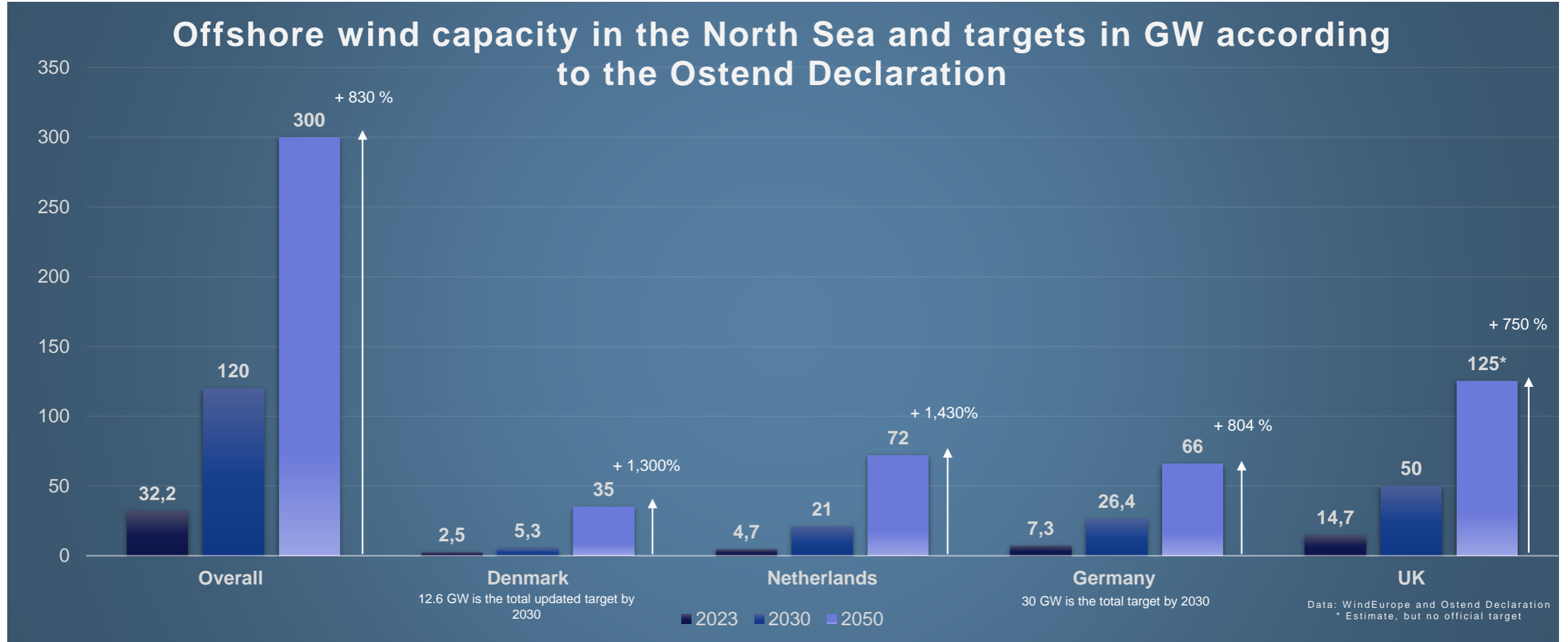
## Selected Policies and Initiatives

- **2016: Establishment of North Seas Energy Cooperation**
  - ❖ Collaboration between Belgium, Denmark, France, Germany, Ireland, Luxembourg, the Netherlands, Norway, Sweden, and the European Commission to coordinate the development of offshore energy and associated grid infrastructure
  - ❖ **October 2023: European Wind Power Action Plan**, which aims to ensure that the clean energy transition goes hand-in-hand with industrial competitiveness
  - ❖ **November 2023: Action Agenda**, which is intended to strengthen European supply chains and move toward an integrated energy system by 2050
- **18 May 2022: North Sea Summit I/Esbjerg Declaration**, Belgium, Denmark, Germany and the Netherlands committed to jointly build **65 GW** of offshore wind energy in the North Sea **by 2030** and **150 GW by 2050**
- **24 April 2023: North Sea Summit II/Ostend Declaration**
  - ❖ France, Ireland, Luxembourg, Norway and the United Kingdom joined the Esbjerg Declaration
  - ❖ All nine countries committed to jointly building offshore wind energy of **120 GW by 2030** in the North Seas and at least **300 GW by 2050**



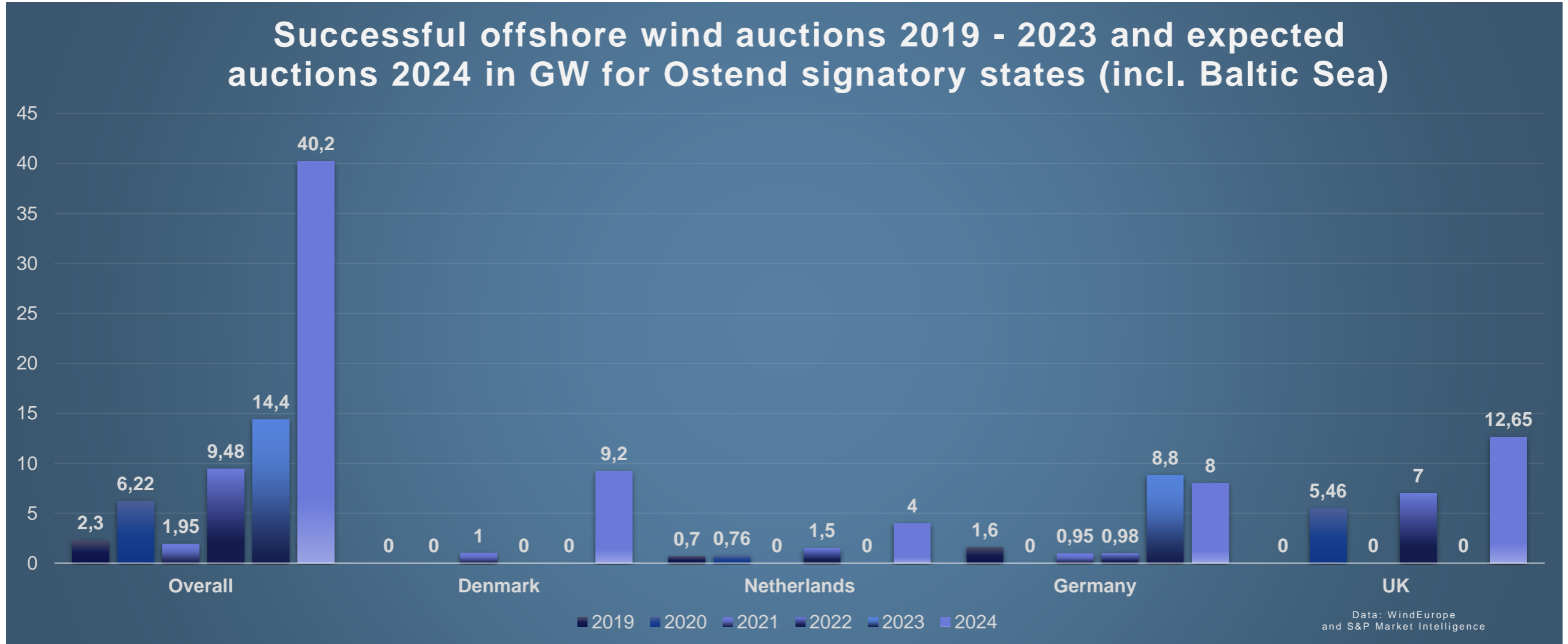

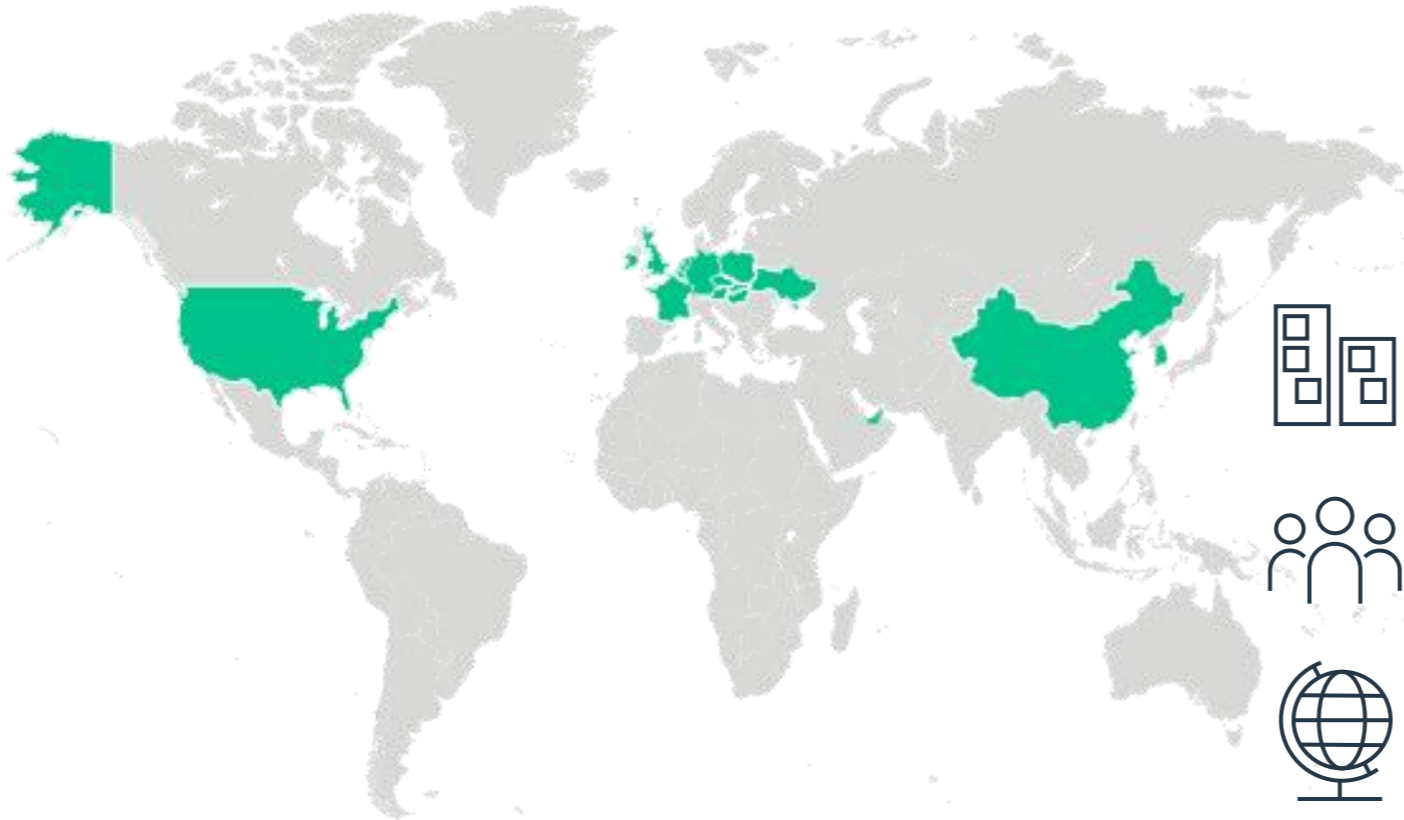

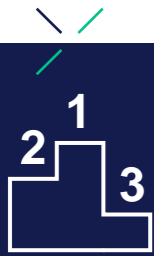
